CALL FOR SERVICE PROVIDERS TO UNDERTAKE STRATEGIES FOR THE CENTRAL KAROO AND ASSIST WITH SECURING FUNDS. (on risk)

CKDM 06 – 2011/12

The Central Karoo District Municipality (CKDM) currently needs to review and update some of its strategies for the District. In addition there is a need for the local municipalities (Laingsburg, Prince Albert, Beaufort West) to also review and update their strategies. Strategies that require updating include the following:

- Central Karoo Integrated Development Plan (IDP)
- Central Karoo Local Economic Development Plan (LED)
- Sector Plans (including Poverty Alleviation Strategy and Critical Infrastructure Plan)
- Local Municipality Economic Development Strategies (Prince Albert, Beaufort West, Laingsburg & Small Towns)
- Local Municipality Integrated Development Plans (Prince Albert, Beaufort West, Laingsburg & Small Towns)
- Skills Capacity and Training

The CKDM has set aside some funding which has been allocated towards the completion of the above projects; however there is a funding shortfall. The District therefore calls on suitable and experienced service providers to assist the District with approaching various funding sources to secure funding to complete the above strategies. This could involve interaction with a number of government, international agencies as well as NGOs. Once the funding has been secured the CKDM will appoint the service providers to undertake the various strategies.

Tenders are hereby invited from service providers for the review and re-development of the CKDM and Local Municipality Strategies. In addition the service providers need to assist the CKDM in accessing the relevant funds to complete the identified studies.
