Tenders are hereby invited in terms of Chapter 11 of the Municipal Financial Management Act, 2003 (Act 56 of 2003) for upgrading of the council chambers and a new emergency exit and stairway at the CKDM Offices, Konstitution Street, Beaufort West.

It is estimated that tenderers should have a CIDB contractor grading designation of 2 GB or 2 CE or higher.

Preference is offered to tenderers who comply with the Preferential Procurement Regulations, 2011, who provides a certified valid B-BBEE Rating Certificate with their completed tender documentation.
